Competitors,

As with many things this year our decoy competition will look much different. Even with the 33rd Annual Decoy Festival being postponed until 2021, we felt that it was possible to provide a good competition while keeping safety in mind. Below are some guidelines to help answer questions regarding the competition and entries.

Dates: Dec 5th and 6th, 2020

Location: H. Curt Salter Building, 1574 Harkers Island Rd., Beaufort, NC 28516.

Entries: Entries can be entered in person at the H. Curt Salter Building Friday Dec 4th from 5:30-7:30 pm, or Dec 5th from 7:30-9:30 am.

Mail-in entries can be sent to W. Stanley Rule, M.D, 3604 Medical Park Ct., Morehead City NC (Mail ins must be received prior to Friday Dec 4th, 2020)

Entry Pickup: Entries must be picked up (unless mailed in and a pre-paid label was provided for return) after decoy judging and photography is complete.

The float tank will be set up in the workshop where judging will take place. While the event will be closed to the public the competition will be live streamed via Facebook and, weather permitting, there will be a viewing area set up outside.

1. There are three levels of competition for the IWCA Decorative Divisions of Competition:

- A. Open
- B. Intermediate
- C. Novice

2. Carver cannot enter the same entry within the same division in this show more than once.

3. All entries must be made of wood, cork, or stretched canvas.

4. Our show complies with IWCA Rules (www.IWFCA.com).

DIVISION H – H. Curt Salter Core Sound Hunting Decoy

Competition

(Purchase Award)

Judging/Entry Rules

1. No eyes (inserted or painted), eye sockets, or channels.
2. Carving is allowed in lower mandible and where bill meets the face, but no nostrils or nails may be carved.
3. No inserts or raised feathers, feather groups, or painted feathers.
4. No burning, stoning, or texturing (must be slick).
5. Painting shall be done in traditional methods of block painting and no antiquing, airbrushing, or blending.
6. No carved flanking or side pockets or relieving of feather groups.
7. Must self right when placed in the water and must have a place for securing anchor line.
8. Must be made from wood, cork, or canvas.
9. There will be no limit on the number or sex of decoys entered.
10. All decoys will be judged in their respective category, marsh ducks, diving ducks, geese and confidence. Final decision will be made from 20 feet.

DIVISION I – Root Head Decoy Competition

(Purchase Award)

Judging/Entry Rules

1. Heads must be shaped from the natural fork of a tree branch or root. No bill detail will be allowed except carving to delineate between the upper and lower mandible and can be shaped to represent the species. No glass eyes may be used.
2. All duck and goose decoys must be equipped with a lead or iron weight attached to the bottom and a leather strap, nail, or staple, attached for securing an anchor line. All Flatties (silhouette shorebird) type decoys must have a wooden dowel or metal rod and base for displaying.
3. Painting shall be simple block style. Stippling, ragging, and antiquing will be allowed. No blending of paint will be allowed
4. All decoys will be judged on the table (non-floating) and the final decision will be made from 20 feet. All materials and methods of construction will be assessed from traditional methods used in constructing Root Head decoys for use in North Carolina and Virginia.

DIVISION J – Contemporary Antique Decoy Competition

Judging/Entry Rules

1. Open to all carvers. Entries can be primitive, classic folk art, or crude. Contestants may submit floating, non-floating, or stick-ups with standard materials (wood, cork, canvas, etc). Entries will not be floated. Categories will be judged separately as marsh ducks, diving ducks, geese and confidence, and shorebirds.
2. Reproductions are discouraged.
3. Entries should be dated and bear a maker's mark.

Best of Show: \$100.00, plaque, plus ribbon.

Second Best of Show: \$50.00, plus ribbon.

Third Best of Show: \$25.00, plus ribbon.

DIVISION K – Youth Decoy Carving Championship

Judging/Entry Rules

No entry fees will apply in the Youth Decoy Carving Competition Division. Youth may enter decoys in the regular competition, and entry fees will apply.

Youth Class A – (YA) 15 – 17 years of age at time of registration.

Youth Class B – (YB) 12 – 14 years of age at time of registration.

Youth Class C – (YC) 11 and under years of age at time of registration.

DIVISION L – Kent Hood Traditional North Carolina Decoy Championship

(Purchase Award)

Judging/Entry Rules

For the purpose of this competition, a traditional North Carolina decoy will be defined as one representing a style made in any region of North Carolina before 1950 (see Styles of Decoys below). The carver's interpretation of these styles is encouraged.

1. Must have a place for securing an anchor line.
2. Must be made from wood, cork, or canvas.
3. All decoys will be judged as a group in their respective category, diving ducks and marsh ducks, from a distance of 20 feet.
4. Reproductions are prohibited.

Styles of Decoys:

The styles of decoys that could be entered into this category would include, but not be limited to: Currituck, Core Sound, Bogue Sound, Knotts Island, Churches Island, Outer Banks, Portsmouth, Ocracoke, and Hatteras. A Core Sound decoy cannot be entered in both the Curt Salter Core Sound Style Division and the Kent Hood NC Decoy Championship in the same show.

The winning decoys (First, Second, and Third Best of Show) become the property of the Kent Hood Decoy Carvers Foundation, Inc.

Best of Show: \$125.00, plus ribbon.

Second Best of Show: \$100.00, plus ribbon.

Third Best of Show: \$75.00, plus ribbon.

Explanation of how the competition would work:

All decoys will be judged as a group in their respective category, diving ducks and marsh ducks (not each species). Judges choose the decoys from each category they would like to have returned for the final judging. The judges will combine the top diving and marsh duck decoys to make their selection of the three winners. Decoys will be judged as they float in the water from 20 feet.

DIVISION M – IWCA Style Shorebird Championship

Best of Show: \$300.00, plus plaque and ribbon.

Second Best of Show: \$200.00, plus ribbon.

Third Best of Show: \$100.00, plus ribbon
